In 2012 the Council also unanimously decided to co-opt Professor Ronan McDonald as an additional Councillor, Ronan having graciously agreed to accept the position.

In addition, Trudi O'Neil kindly continued to perform the invaluable role of Minutes Secretary, and past President Patrick Tansey generously took on the lion's share of the work in relation to organising our three main annual functions, with the assistance of course of Maureen McLoughlin. MEMBERSHIP

The Society has 73 financial members and 4 honorary life members. This year there were also two honorary members, being the 2011 winners of the Aisling Society Prize at the Universities of Sydney and NSW, and we welcomed one new member, namely Orla Saul.

ANNUAL GENERAL MEETING

The 2012 Annual General Meeting was held on Wednesday 22 February. The Annual Report for 2011, which had been prepared by Peter Gray and circulated to members beforehand, was presented, as was the Treasurer's report which had been prepared by Maureen McLoughlin and likewise circulated. Both these reports were accepted.

An Election of Office-Bearers was held, resulting as set out above. Maureen McLoughlin stepped down as Treasurer after serving in that role for some 39 years. Maureen's magnificent contribution to the Society has been incalculable, and we are delighted that she has continued as a councillor.

ORDINARY MEETINGS

Our ordinary monthly meetings were held once more in the rooms of the Consulate-General of Ireland, for whose support and generosity we are again most grateful. Again we had the advantage of the genuine interest of the Consul-General, Caitriona Ingoldsby, and of the Vice-Consul, Siobhan Kelly Antonucci.

from Ardmore on the coast of Waterford to Cashel in Tipperary.

We welcomed Dr Liam Weeks, lecturer in politics at the Department of

Government, University College Cork, who illuminated some of the similarities and differences in the Irish and Australian electoral systems. in his Talk entitles "De minimis non curat praetor: voting system design in

Ireland and Australia".

JUNE Dr Desmond O'Malley, a Joyce scholar who lectures on Irish language

> and literature at Sydney University, shed a fascinating light on the intrinsic Irishness of much of the English spoken and used by Joyce's

characters in "The secret language of James Joyce".

The first performance of Handel's "Messiah" took place in Dublin on 13

April 1742. Why Dublin? What was Handel doing there? In "Handel in Dublin 1741-2", Professor Barra Boydell, retired Professor of Music History at the National University of Ireland Maynooth and joint editor of the Encyclopedia of Music in Ireland, teased out some of the answers to

such questions.

Steve Carey, Chairman of the NSW GAA, entitled his Talk "The GAA: a

national heritage". Steve discussed the origins and development of the GAA, as well as its enormous and ongoing impact on Irish life both at

home and abroad.

Author and broadcaster Claire Dunne explored the Irish harp as the

central icon of a nation's story in "Irish harps in time - mythic, cultural, historic". She illustrated the story beautifully by playing, on her own harp,

some of the well-loved pieces associated with the instrument.

ST PATRICK'S DAY DINNER:

This year's party was held on Wednesday 28 November at Sancta Sophia College at Sydney University. The party was as usual a very enjoyable and convivial evening, and was attended by 55 members and friends.

AISLING SOCIETY MILESTONES IN 2012

- The Aisling website aislingsociety.org.au was launched, thanks in large part to the hard work of Tony Earls, assisted by Peter Gray and Jeff Kildea. The site contains a wealth of information about the Society, including something of its history, lists of Talks and publications, a calendar of events (which Jeff Kildea is keeping updated), and several useful links to other sites such as the Irish Embassy and Consulate, and the Irish-related Departments at both Sydney University and UNSW.
- Claire Dunne's latest book, Carl Jung: Wounded Healer of the Soul, was published in May.
- During the year Anne Stevens very kindly made all the necessary arrangements to have the audiotapes of the interviews conducted for the oral history of the Society, a project dating back to 2000, transformed into digital form. We hope that before long these will be available on our website.

EVENTS DURING THE YEAR IN WHICH MEMBERS OF THE SOCIETY PARTICIPATED

- Patrick Tansey co-ordinated the organisation of the traditional "Aisling car", and phalanx of supporting decorators and walkers, for our participation in the annual St Patrick's Day Parade in March.
- The Society again made donations to the St Patrick's Day Mass Committee and to the St Patrick's Day Parade Committee.
- Vice-president Mary Lee represented the Society at a ceremony held by the Faculty of Arts and Social Sciences at UNSW in March, when our prizes in both English and History were awarded to Brooke Boland
- Our immediate past president Patrick Tansey represented the Society at a ceremony held by the School of Philosophical and Historical Inquiry at Sydney University in May, when our prize was awarded to Patrick Wilson
- Bloomsday celebrations were centred this year on the Bondi Pavilion, masterminded by our member Ronan McDonald and enjoyed by many of our members
- On 26 July, Consul-General Caitriona Ingoldsby kindly hosted a reception for "members of the legal profession with Irish connections in Sydney". Tony Baine, Tony Earls, Jeff Kildea and Peter Gray were among the Aisling members who enjoyed the occasion

- In October, one of the regular UNSW Global Irish Studies Talks took the form of a seminar chaired by our member Tony Earls, under the title 'Irish Lawyers in colonial Australia 'significant yet indefinable'?
- Professor Cormac Ó Gráda of University College Dublin delivered the second annual Patrick O'Farrell Memorial Lecture at the John Hume Institute for Global Irish Studies at UNSW on 5 November: 'Because she never let them in': Irish immigration a century ago and today. Numerous Aisling members were present, both for the lecture itself (in honour of our distinguished former life member) and at the reception for Irish Studies supporters beforehand graciously hosted by the Chancellor, David Gonski AC and the Dean, Professor James Donald.
